Campaign to Save USDA Rural Water Funding Success: Approximately one month after the President's budget proposed eliminating all USDA rural water funding, USDA Secretary Perdue testified before Senate Committee on Commerce in support of the USDA rural water initiatives. On Wednesday, Secretary Perdue said, "Continued rural infrastructure investments for water, wastewater, and solid waste systems in small town America is crucial. The demand for water investment is great, with demand that exceeds the federal government's ability to support. Today, the USDA rural water program has a backlog of more than \$3.1 billion projects awaiting funding and financing. States with the highest backlog of requests for federal loans and grants include Indiana, Illinois, Michigan, Minnesota, Missouri, Oklahoma, New Mexico, Texas, Washington, and West Virginia (USDA)."

Senators Wicker (MS), Hatch (UT), Rubio (FL) and Burr (NC) Question EPA on Allowing Small Communities to Delivery Tier 2 Notice with Internet: This effort was initiated in 2015 by Senator Wicker who initially inquired about it to EPA (6/11/15). Subsequently, Senator Hatch (1/11/18) made an inquiry, and electronic mail correspondence was transmitted to EPA from Senators Burr and Rubio. Last week, the Agency replied that, "EPA will continue to discuss the important issue of electronic delivery of certain public notices... as resources allow (3/13/18, EPA to Senator Hatch)." However, it appears the Agency had previously determined that the relief we are requesting is authorized. In the EPA response to Senator Wicker (8/5/16), EPA finds that "Tier 2 requires mail or direct delivery with the bill and a method to notify those who do not receive a bill or do not have service connection addresses (such as renters, apartments, nursing homes, etc.). Posting on the internet is allowed as one of the methods to reach those consumers." The relief is not being realized by small and rural communities because the Agency has not updated their January 3, 2013 Policy Memorandum which limits the delivery flexibility to Consumer Confidence Reports. Trump Administration Blames Russian Government for Cyberattacks on U.S. Utilities: A Department of Homeland Security security memo characterizes the cyberattacks as a "multi-stage intrusion campaign by Russian government cyber actors who targeted small commercial facilities' networks." The New York Times says the memo screenshots indicate the Russian hackers had enough control of the systems that they could have manipulated or shut down the power plants. Treasury Secretary Steven Mnuchin said, "Since at least March 2016, Russian government cyber actors have also targeted U.S. government entities and multiple U.S. critical infrastructure sectors, including the energy, nuclear, commercial facilities, water, aviation, and critical manufacturing sectors."
