Week in Review March 24, 2017

EDUCATION

Sen. Matt Huffman's (R-Lima) proposal to establish a unified school voucher program and educational savings accounts (ESAs) creates a "state preference for private schools," Senate Education Committee Chairwoman Peggy Lehner (R-Kettering) said Wednesday.

ELECTIONS 2018

U.S. Rep. Jim Renacci (R-Wadsworth) ended speculation about his 2018 plans Monday, becoming the second Republican to officially enter the gubernatorial race, with at least two more expected to follow him. Renacci, a supporter of President Donald Trump, adapted Trump's "America First" slogan with an "Ohio First" theme to his campaign. In his announcement, he said that career politicians in Washington and Columbus have been looking out for themselves for too long.

GENERAL ASSEMBLY/STATEHOUSE

The Senate unanimously passed the \$7.8 billion transportation budget during a brief session on Wednesday. The Ohio House set up the transportation budget, HB 26 (McColley), for conference committee Wednesday after denying concurrence on Senate changes.

The conference committee for HB 26 (McColley) will hold its first meeting Monday at 3 p.m. in Room 313 of the Ohio Statehouse. Members will include Reps. Ryan Smith (R-Gallipolis), Robert McColley (R-Napoleon) and Alicia Reece (D-Cincinnati) and Sens. Frank LaRose (R-Copley), Scott Oelslager (R-North Canton) and Charleta Tavares (D-Columbus).

GOVERNOR

The governor made the following appointments during the week:

- Will Lucas of Toledo (Lucas County) reappointed to the Ohio Casino Control Commission for a term beginning March 17, 2017, and ending Feb. 21, 2021.
- Jason Clark of Miamisburg (Montgomery County) reappointed to the Ohio Housing Finance Agency for a term beginning March 17, 2017, and ending Jan. 31, 2023.
- Randall W. Leite, Ph.D. of Pickerington (Franklin County) reappointed to the Ohio Commission on Fatherhood for a term beginning March 17, 2017, and ending July 30, 2018.
- Mark Johnson of Chillicothe (Ross County) to the Ohio Rail Development Commission for a term beginning March 17, 2017, and ending Oct. 20, 2021.
- Dr. Kim G. Rothermel of Columbus (Franklin County) reappointed to the State Medical Board for a term beginning March 20, 2017 and March 18, 2022.
- Michael Miller of Powell (Delaware County) reappointed to the Ohio Public Works Commission for a term beginning March 20, 2017, and ending March 18, 2021.
- Dennis M. Bartels of Gahanna (Franklin County) reappointed to the State Board of Career Colleges and Schools for a term beginning March 20, 2017, and ending Nov. 20, 2021.
- James C. Oda of Piqua (Miami County) to the Edison State Community College Board of Trustees for a term beginning March 23, 2017, and ending Jan. 17, 2023.
- David M. Reynolds of Solon (Cuyahoga County) to the Cleveland State University Board of Trustees for a term beginning March 23, 2017, and ending May 1, 2025.

HEALTH & HUMAN SERVICES

The Baby Box Co., the company behind the global program Baby Box University, recently announced that Ohio is the second U.S. state to launch a universal program where all expecting and new parents can receive a free Baby Box by completing online parenting education. Baby Box University aims to improve family health care outcomes and reduce Sudden Unexpected Infant Death Syndrome (SUIDS).

Gov. John Kasich announced Monday that he is appointing Lance Himes to serve as acting director of the Ohio Department of Health (ODH). Himes currently serves as the department's chief legal counsel and served as acting director earlier in the administration. Himes replaces the department's

current director, Rick Hodges, effective Friday, March 31. Hodges announced that he is leaving to pursue new opportunities outside of the administration.

Upward of 50 witnesses appeared before the House Finance Health and Human Services Subcommittee Wednesday afternoon and evening, some supporting provisions included in the proposed budget while others sought funding for their agency or cause. Others sought changes.

HOUSING

The Coalition on Homelessness and Housing in Ohio (COHHIO) is hosting the annual Housing Ohio conference in Columbus from April 10-12. Housing Ohio 2017 offers the choice of 30 workshops presented by practitioners and national experts said to have taken innovative approaches to a wide variety of homelessness and affordable housing issues.

TRANSPORTATION

Ohio Trucking Association President Tom Balzer joined several legislators and other industry representatives Wednesday in announcing upcoming steps to address a growing job shortage in the industry.

WORKERS' COMPENSATION

House Speaker Cliff Rosenberger (R-Clarksville) said Wednesday that workers' comp coverage for first responders diagnosed with post-traumatic stress disorder (PTSD) could proceed as an amendment to the agency's budget or emerge in a standalone bill; on Thursday, Sens. Frank LaRose (R-Copley) and Edna Brown (D-Toledo) introduced legislation that would provide PTSD benefits to police and firefighters without the need for an accompanying physical injury.
