

Other items that are being affected:


Fuel Surcharges - Cost of fuel is rising dramatically due to major refinery shutdowns

Lead-times and Trucking – lead-times for deliveries will be lengthened even further. The storm has exasperated an already tight trucking market.

Deposits for containers – the plastic resins are not available right now to make drums and totes. The container manufacturers are declaring Force Majeure. We need to charge deposits so that we assure we get our containers back
