Week in Review Monday, October 12, 2015

As a service to the clients and friends of Governmental Policy Group, Inc. and RH Resources we would like to extend the following weekly update of events happening around Capitol Square.

# **AUDITOR OF STATE**

Auditor Dave Yost released special audit findings for a now-defunct tutoring program in Columbus City Schools, showing improper payment of hundreds of thousands of dollars for tutoring that never happened or was for students who weren't in the district. He also announced the unsealing of a federal indictment against one tutoring provider.

## **BALLOT ISSUES**

Ohio would earn tax revenues of \$133 million to \$293.3 million within a year after all marijuana growing facilities and retail stores are open, a fiscal analysis of Issue 3 released by the Office of Budget and Management (OBM) says. The projections are much less than what an analysis by ResponsibleOhio, the group behind the legalization effort that is in Issue 3, found in

March. That group projected \$554 million in tax revenue by 2020, estimating that Ohioans would use more than 244 metric tons of marijuana and sales would hit nearly \$2.3 billion.

#### **CIVIL RIGHTS**

The U.S. Department of Housing and Urban Development (HUD) announced recently that it is awarding over \$1.9 million under HUD's Fair Housing Initiatives Program (FHIP) to six organizations in Ohio to fight housing discrimination.

#### **CRIMINAL JUSTICE**

The American Civil Liberties Union (ACLU) of Ohio and the Buckeye Institute for Public Policy Solutions joined forces last week with a message for the General Assembly: Don't increase any more criminal penalties until the efforts of the Criminal Justice Recodification Committee are complete. The ACLU also released a report with an analysis of 54 new bills introduced so far in the 131st General Assembly, or about 11 percent of the total number of bills introduced in both chambers, that would send more people to prison and jail. The group said that the new bills are counterintuitive to criminal sentencing reform efforts.

# **EDUCATION**

House and Senate conferees agreed unanimously last Tuesday to a compromise version of charter school reform measure HB 2 (Dovilla-Roegner), adopting changes meant to prevent a repeat of recent problems with sponsor evaluations and to counteract the effects of a recent Ohio Supreme Court ruling on ownership of charter school property. The legislation drew broad support in final votes last Wednesday, passing the Senate unanimously and the House with just six dissenters. Latebreaking pension system changes caused some grumbling and a handful of no votes, but lawmakers overall lauded the conference committee's version of HB 2 as likely to promote quality schools and rein in abuses.

Auditor of State Dave Yost said he'll be looking for the Ohio Department of Education (ODE) to take special care in distributing money from its recent \$71 million federal grant for charter schools. The grant award has prompted calls from charter school critics in Ohio to call on USDOE to reconsider the award or attach special restrictions to its disbursal, given recent controversies in the charter sector, including the withdrawal of sponsor ratings.

#### **ELECTIONS 2016**

Rep. Denise Driehaus (D-Cincinnati) opened her campaign for Hamilton County commissioner this week and will challenge incumbent Republican Greg Hartmann in 2016. Driehaus is term-limited next year and cannot run for re-election to the House.

Rep. Bob Hackett (R-London), who is term-limited at the end of this session, stated that he is considering running for the Senate in 2016. Sen. Chris Widener (R-Springfield) is term-limited at the end of this session as well, leaving the 10th Senate District as an open seat.

While Rep. Cheryl Grossman (R-Grove City) has announced a bid for the 16th Senate District in 2016, the Senate Republican Caucus is putting its support behind Rep. Stephanie Kunze(R-Hilliard). Grossman is term-limited, while Kunze is in her second term in the House. If Kunze were to run for the Senate, her House seat would be open, allowing current Sen. Jim Hughes (R-Columbus) to run for it.

#### EMPLOYMENT/UNEMPLOYMENT

The nation added 142,000 jobs in September and the unemployment rate remained unchanged at 5.1 percent, the U.S. Bureau of Labor Statistics (BLS) announced on Friday.

# **ENERGY**

Energy Mandates Study Committee Co-Chair Sen. Troy Balderson (R-Zanesville) said he was caught off guard by the Kasich administration's negative response to the panel's report, which calls for an indefinite freeze of Ohio's clean energy standards. Joe Andrews, Gov. John Kasich's spokesman, said the committee's recommendation was "unacceptable" shortly after the report's recent release.

## **ENVIRONMENT**

The Ohio Environmental Protection Agency (Ohio EPA) announced it has opened an initial comment period related to the agency's new draft rules for public drinking water systems and laboratories as it relates to the reporting and monitoring of harmful algal blooms (HABs).

## **GAMING**

Ohio's four casinos saw a drop in revenue from August to September, but numbers were up from the same period in 2014, the Ohio Casino Control Commission announced this week. According to the commission, all four casinos earned about \$64.3 million in September, down from \$66.3 million in August. In September 2014, the casinos earned \$63.3 million.

#### GENERAL ASSEMBLY/STATEHOUSE

On Tuesday, representatives for Uber and the insurance industry testified in support of HB 237 (Duffey-Hackett), the compromise rideshare regulation bill, before the Senate State and Local Government Committee. Testimony was offered by John Koetz on behalf of the Professional Independent Agents Association of Ohio, Inc. (PIAAO) and Robert Kellman, manager of public policy issues for Uber.

House Speaker Cliff Rosenberger (R-Clarksville) sent out a revised House schedule last Thursday that did the following:

- Canceled if-needed House sessions on Wednesday, Oct. 14 and Tuesday, Nov. 10.
- Added a House session on Tuesday, Oct. 27 and Tuesday, Dec. 1.
- Added an if-needed session for Wednesday, Nov. 18.
- Canceled the House session set for Wednesday, Dec. 2.

## **POLITICS**

Senate President Keith Faber (R-Celina) said last Wednesday he won't seek to replace U.S. House Speaker John Boehner (R-West Chester) in the special election that will follow Boehner's planned departure from the House at month's end. "My wife and family and friends determined that isn't the right seat, it's not the right time, and it's not the right job for me right now," he said after last Wednesday's Senate session.

## **PUBLIC SAFETY**

With 97 fire deaths so far this year, Ohio Department of Commerce Director Jacqueline Williams announced a new effort by the Kasich administration to reduce that number. Williams, State Fire Marshal Larry Flowers and other state officials were on hand Monday to discuss the "Safe & Sound" campaign, which will encourage smoke alarm use and educate Ohioans on fire risks from heat sources during winter. Other state agencies joining the initiative include the Ohio Department of Aging (ODA), Ohio Department of Agriculture (ODAg), Ohio Department of Public Safety (ODPS) and Ohio Development Services Agency (DSA). The American Red Cross will also assist with the campaign.

## **TAXATION**

State tax revenues came in about \$34 million below estimates in September, putting Ohio 0.4 percent behind projections for the fiscal year to date but still \$300-plus million ahead of what it had collected in the first three months of the previous fiscal year.

# TRANSPORTATION

Ohio Turnpike and Infrastructure Commission (OTIC) Executive Director Randy Cole told legislators that raising the speed limit on the Northern Ohio roadway would almost certainly lead to more crashes. According to OTIC data, there has been a 14.5 percent increase in fatal crashes, a 9.1 percent hike in injury crashes, a 12.6 percent jump in property damage crashes, and a 12 percent rise in total crashes since the implementation of the 70 mph speed limit in April 2011. However, he did not place all the blame on the higher speed limit.
