Asset Management Planning Assistance Agreement	
I,, certify that the Public Water System in which I am employed, (the "System"), is an active member of	
the Ohio Rural Water Association (ORWA), that I am authorized to purchase products and services on	
behalf of the System, and that I will be the primary person responsible for the planning and development of the System's Asset Management Program. I am authorizing ORWA to purchase and create an ESRI ArcGIS Online account on behalf of the System. The current annual cost of maintaining this account is \$1,100.00. The cost of maintaining the account during the first year only shall be paid by ORWA. The ArcGIS account will be used to map our water system utility assets in accordance with Ohio EPA's Asset Management Program requirements. Subsequent year renewals shall be at the System's discretion.	
ORWA will serve as the Administrator of the System's GIS map for the first ESRI subscription year.	
As the Administrator:	
ORWA will setup the System's Water Utility GIS map with the basic functionality to create a	

- complete Water System asset map;
- ORWA will provide on-site training assistance in the collection and editing of assets;
   ORWA will provide technical assistance related to the map;
- ORWA will provide the necessary equipment to collect assets if the System is unable to acquire their own, and the equipment is available;
- > ORWA will provide on-going yearly map update assistance on a limited basis; and
- ORWA will restrict access to the System's map to only employees and agents of ORWA and the System.

\*Due to resource limitations, all of the items listed above will be contingent upon time and personnel availability.

To safeguard ORWA's time and efforts in assisting the System's development of an Asset Management Program, the System agrees to:

- Adhere to ESRI's user Master Agreement found at http://www.esri.com/legal/software-license;
- Use best efforts to collect and submit as much asset information as reasonably possible during the first year;
- Share with ORWA the Username and Password during the first year so as to allow ORWA access to the System's map;
- Allow ORWA to download and store the System's map information for safekeeping at all times;
- Allow ORWA to maintain a copy of the System's map to be used by ORWA's field staff to enhance their ability to provide technical assistance in the future;
- Utilize the map only for the development and improvement of the System's Asset Management Program;
- Complete and execute an ORWA Equipment Rental & Operating Agreement prior to renting any equipment owned by ORWA, and properly maintain such equipment while it is in the System's possession or control; and
- Notify ORWA at least seventy-two (72) hours prior to termination of this agreement.

#### Subsequent Years:

\$1,100/yr – The cost to retain 2-full access ArcGIS Online user accounts (paid by you to ESRI)
