**Week in Review**  
May 31, 2016

**ADDICTION/SUBSTANCE ABUSE**

The Joint Medicaid Oversight Committee spent its meeting last week reviewing addiction treatment and recovery systems in Ohio. Dr. Mark Hurst, medical director of the Ohio Department of Mental Health and Addiction Services (OhioMHAS), led off a panel that also included Lori Criss of the Ohio Council of Behavioral Health Providers; Cheri Walter of the Ohio Association of County Behavioral Health Authorities; Kathryn Spergel of Mental Health and Recovery of Licking and Knox Counties; and Wendy Doolittle of McKinley Hall, a Springfield provider organization.

**AGRICULTURE**

Legislation requiring the Ohio Department of Agriculture (ODAg) to regulate pet stores statewide could make Ohio the toughest state in the nation when dealing with irresponsible pet providers, SB 331 sponsor Sen. Bob Peterson (R-Sabina) said last week. The bill was introduced after a contentious hearing on a similar amendment -- since withdrawn -- in the Senate Ways and Means

Committee. Opponents said the amendment would make it easier for pet stores to obtain animals from "puppy mills," while proponents said it would hold irresponsible pet providers accountable while ensuring responsible pet stores can remain open.

## **AUDITOR OF STATE**

The Ohio Department of Education (ODE) might be the worst run agency in state government and should have some of its functions given to other departments, Auditor Dave Yost said last Monday. Yost had called the press conference to release results of his latest spot-check of attendance at Ohio charter schools but used the platform for a broader critique of state education governance. Problems flow from the agency's varying duties as a funder, licenser, regulator, advocate and database administrator, he said.

## **EDUCATION**

Auditor of State Dave Yost released the results of his latest spot-check of attendance at Ohio charter schools, finding 7 percent of schools with attendance severely below what the schools reported to the state, an improvement from the 23 percent figure in the previous attendance audit. The audit also reviewed 14 dropout prevention and recovery schools and found attendance rates of 50 percent or below. While those numbers are concerning, they also indicate attendance data might not be the best way to provide funding to those schools, given the at-risk population they serve, he said.

Reforms to high school equivalency programs and a funding solution to increase access for private school students to College Credit Plus are among new proposals attached to CPR instruction measure HB 113 (Grossman-Manning) after the Senate Education Committee turned it into an omnibus for school issues and reported it out last Tuesday. The bill ultimately cleared the Legislature last Wednesday and is now headed to the governor for his signature.

## **ELECTIONS 2018**

Attorney General Mike DeWine's office responded to media reports that he had "confirmed" a run for governor in confidence, saying the revelation was nothing new. "Attorney General DeWine has stated in many recent interviews that he fully intends to run for governor in 2018 but has not yet made a formal announcement," AG spokesman Dan Tierney announced.

## **EMPLOYMENT/UNEMPLOYMENT**

Ohio's unemployment rate was 5.2 percent in April, up from 5.1 percent in March, as the Buckeye State shed 13,600 jobs, the Ohio Department of Job and Family Services (ODJFS) announced. The April jobs report is in contrast to the March report, which showed the state gaining 18,300 jobs.

## **ENVIRONMENT**

The Ohio Environmental Protection Agency (Ohio EPA) is seeking public comment on its draft Western Lake Erie Basin Collaborative Agreement Implementation Plan to reduce phosphorus entering Lake Erie by 40 percent by 2025. The document shows how the state will implement the agreement, which was signed in June 2015 by Lt. Gov. Mary Taylor, Michigan and Ontario with a goal of reducing phosphorus loading to Lake Erie by 20 percent by 2020 and by 40 percent by 2025.

The Ohio Environmental Protection Agency (Ohio EPA) announced it has begun a water quality study of the Huron River watershed in Crawford, Erie, Huron, Richland and Seneca counties.

## **GENERAL ASSEMBLY/STATEHOUSE**

The Legislature's Correctional Institution Inspection Committee (CIIC) had a near miss last week as the Senate agreed to reinstate the 40-year-old entity in more or less its existing form, sans Director Joanna Saul. The Senate Ways and Means Committee re-amended CIIC into unrelated legislation, HB 390 (Schaffer-Retherford), after approving its dissolution in a substitute version of the same bill earlier. During a press gaggle, Senate President Keith Faber (R-Celina) said Saul, who would resign after firing off an angry letter to the Senate, had been "grossly insubordinate" to Hite and former senator and CIIC chairperson Shirley Smith.

## **MARIJUANA**

Medical marijuana legalization is headed to Gov. John Kasich's desk after HB 523 (Huffman) cleared its last major hurdles last week with narrow votes for approval in the Senate. The measure cleared the Senate Government Oversight and Reform Committee on a 7-5 vote in the morning after a final round of changes. The full Senate voted 18-15 to approve it later in the day, followed by House concurrence with the Senate amendments on a vote of 67-28.

## **NATURAL RESOURCES**

Dam safety improvements at Buckeye Lake over the past eight months allow for water levels to safely increase two feet above the current three-foot winter pool, allowing more boaters to return to the lake, the Ohio Department of Natural Resources (ODNR) announced last Thursday.

## **PEOPLE**

Jai Chabria, a long-time adviser to Gov. John Kasich, will be opening up an Ohio office for Mercury, a public strategy firm, the company announced. Chabria is currently working with the Ohio Republican Party to help oversee the preparation and planning for the Republican National Convention in Cleveland in July. Previously, he worked on the executive staff of the Kasich administration.

## **TREASURER OF STATE**

Treasurer Josh Mandel announced the birth of his third child Friday. Gideon Tzvi was born May 12 and weighed 10 pounds, 3 ounces at birth. He joins siblings Rosie and Judah.

## **UTILITIES**

Indiana-based Midcontinent Independent System Operator (MISO) Energy, announced the hiring of now former Public Utilities Commission of Ohio (PUCO) Chairman Andre Porter as its new corporate general counsel, replacing longtime MISO counsel Steve Kozey.

The PUCO is now taking applications for Porter's seat through the close of business on Wednesday, June 1. Its Nominating Council will interview applicants and forward four names to the governor, who will then have 30 days to appoint one of the nominees or request new names from the Nominating Council. His appointee will serve until April 10, 2020.

## **WORKERS' COMPENSATION**

Ohio Bureau of Workers' Compensation (BWC) Administrator/CEO Sarah Morrison credited strong investment returns over the last 10 years for the bureau's latest employer rebate, a \$15 million bonus to the 88 county governments. She said a larger rebate of the sort awarded in 2013 and 2014 under the governor's "Billion Back" program will likely have to await improving interest rates in the near term, as BWC returns have dropped from a high of 13.4 percent in FY14 to low single digits in FY15-16.
